From there, you can access our frequently asked questions as well as **the regulations that list the law label requirements and approved material terminology**. The color of your label must be white and paper labels are **NOT** permitted. Approved materials for labels are Dupont's Tyveck, Van Leer's Valeron, Mohawk Synthetic Premium Polyester and other materials that will not tear or fray.

This registration applies only to bedding and upholstered furniture that is manufactured at the factory location listed on the certificate. If an importer is also listed on the certificate, the registration applies only to the bedding and upholstered furniture that the factory location manufactures for the listed importer. Each factory location must obtain their own certificate, either solely or jointly with a specific importer. The registration must be renewed annually. Renewal forms will be sent to you.
